## **ACTIVITY REPORT**

### RESEARCH

As regards its focus and sequencing, the work on the project followed the original outline and the time schedule. The major modification concerned the inclusion of a study visit to the Norwegian Human Rights Centre in Oslo. The seven-days-long study trip undertaken in February 2004 was originally not planned. Yet, it turned out to be very beneficial (see below).

Four major research areas have been identified at early stages of the research: (1) international context, in particular the concept and role of national human rights institutions, (2) institutional aspects of the domestic non-judicial human rights protection machinery, (3) non-state sector, and (4) the protection mechanism in action. Research of the areas (1) – (3) has been completed in the first stage. In the second stage, *i. e.* after submitting of the interim report, the work on the protection mechanisms in action, which involved several case studies, led to no sizeable findings. On the other hand, the preliminary results indicated that more attention should be paid to the role of human rights research and the evolving think tank sector. This led to the replacement of planned chapter dealing with case studies by a chapter examining human rights research and policy analysis (universities, Academy of Sciences, role of classical think tanks and new advocacy groups). Since the work on the closely related issue - the establishing of an equality body requested by the EU legislation - had progressed, the issue was also included in the study. Finally, the policy options have been identified and evaluated and a set of recommendations devised.

#### REASEARCH RELATED ACTIVITIES

Integrating the international dimension into the research was an impetus for developing personal contacts with other researchers working on the national human rights institutions worldwide. This turned out to be particularly fruitful, as the national human rights institutions are new actors on the international scene and consequently, it is also a relatively new and expanding research area. Contacts with some foreign national institutions (e.g. Norwegian Centre for Human Rights, the German Institute for Human Rights) and the relevant UN bodies have been established. Several informal interviews with relevant decision makers and informants have been conducted. The visit to Norwegian Centre for Human Rights turned out to be particularly enlightening, as it allowed a better understanding of the nexus between particular societal conditions and the role assigned to the NHRI. In addition, it allowed the completion of theoretical research on NHRIs using the unique human rights library of the Centre.

#### **IPF SEMINARS**

I participated in both the March and June 2003 IPF seminars and the 2004 March seminar. I also made full use of the CEU library and research facilities. During seminars, I consulted with Budapest-based mentor Prof. Július Horváth.

# PARTICIPATION IN CONFERENCES, SEMINARS

As part of the activities carried out within the framework of the project, I participated in the Sixth International Seminar Democracy and Human Rights in Multiethnic Societies organised by the Institute for Strengthening Democracy in Konjic, Bosnia and Herzegovina on 7-11 July 2003. I delivered a paper entitled: Human Rights Protection in the Czech Republic: the Changing Role of the Civil Society. I also chaired one of the discussion panels.
