Introduction:

The interim activity report highlights key events and developments since the fellowship program started. Overall the fellowship has enabled me closely examine copyright-related questions in the African context specifically in research and educational settings. My research and advocacy activities happened in a context where there is general awareness of intellectual property but national laws reflect fairly recent trends at the international scene. The mismatch between legal and policy infrastructure, on one hand, and general practice is of dire concern in Uganda and elsewhere in Africa and indeed much of the global south.
