### **Activities like President of “[AER PUR Romania](#)”**

I start my activity in tobacco control field in 1994, when I create the first NGO for non-smokers rights in Romania; NGO with activity in tobacco control field.

During last six years, I gradually developed a sense of anti-smoking advocacy, mainly for two reasons: first, because it caused me pain to see obvious signs that friends and people around me were ruining their health by smoking. Second, because I grew more aware of the discomfort and health risks of second-hand smoking.

In August 1995 I obtain the acceptance of our Romanian organization in the European Union of Non-smokers; it was first organization from Eastern Europe.

1996 was the year when I begin to participate to GLOBALINK and INGCAT.

Our organization has a meeting, and I prepare this, with WHO delegation in Romania at the beginning of 1996.

In July 1997 I organize in IASI Romania the first General Assembly of European Union of Non-smokers in an East European country. This meeting was first manifestation for non-smoker's rights in Romania.

In August 1997 USA TODAY present like Cover Story details about my activity in tobacco control field.

During 1998 I consolidate our organization, AER PUR ROMANIA, like a good reference in tobacco control.

1999 - 2000 National Co-coordinator for QUIT & WIN Campaign in Romania. Event organized in cooperation with Public Health Institute Bucharest, Pharmacia & Upjohn and GlaxoSmithKline Romania with support of World Health Organization and National Public Health Institute Finland.

2001 – We organized first session of training courses for Romanian doctors.

2001-2002 QUIT & WIN Campaign in Romania. Event organized in cooperation with Public Health Institute Bucharest and GlaxoSmithKline Romania with support of World Health Organization and National Public Health Institute Finland.
